Ms. Haswell reported on a few new laws passed regarding motorized scooters. The new laws require anyone under the age of 16 to wear a helmet and you must be 16 years of age or older to operate. Ms. Haswell stated that motorized scooters and electric bikes fall under the same State laws.

Ms. Haswell reported low hanging trees near the Daisy View area, and some properties need tending to but are vacant.

Ms. Haswell asked on behalf of Mr. Zandron if he could have tiger paws painted on the street in front of Carilini's Pizza. All agreed not to allow tiger paws to be painted on the street in village limits.

Mr. Parr suggested a few ideas for the swimming pool no longer in use. One being a grant for a splash pad and Mr. Gorrell added the possibility of a pavilion next to it. There was much discussion, and tabled for a later date with Mr. Parr stating he would speak to Ms. Tamburin about some possible grant options.

Mr. Parr reported a plaque was placed in the median for Mr. Kaluger. Mr. Parr said he had the understanding that Council agreed on a 4x8 brick. Mayor Newhart stated he would speak to them about replacing the plaque with the agreed-upon brick.

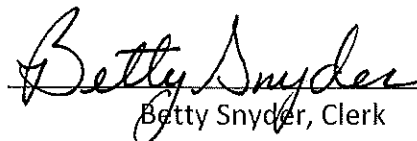

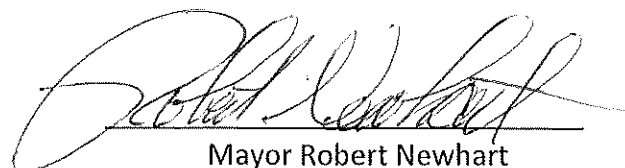
